MEET DIRECTORS PUT THEIR RESPECTIVE MEET INTO THE GYMJAS SYSTEM. MEET DIRECTORS CAN:

- 1. Request specific judges
- 2. Request local judges
- 3. Request judges with a certain rating
- 4. Request their meet referee



- 1. Judges are contacted via email if they have been requested for a meet. If a judge is requested for more than one meet on the same weekend, the judge chooses which meet he/she would prefer. A judge choosing one meet over another is kept confidential.
- 2. When local judges are requested, the assign appropriate rating to assign to that meet. A r full number needed.

- 3. The chief judge on bars will always serve as meet referee, unless there is a stand-alone meet referequested. For larger invitationals, the meet ref may choose event assignments. Otherwise, the event assignments come from the assigner and will be assigned in the GymJas system. *The meet ref is not always the highest rated official. There may be times when a higher rated judge will serve as the panel judge on bars to mentor a first time meet ref.
- 4. Fall assigning officially begins August 3rd. Winter/Spring assigning officially begins September 15th. Not inputting your availability on time, can affect your assignments. If a judge does not

include Friday on their availability or vice versa, Sunday, this will affect your opportunity to be assigned to a 3-day competition. Meets with requested judges may be assigned earlier than the date listed. The hope is for all Winter/Spring meets to be assigned before October 1st. This will help when NCAA begins to assign judges.

- 5. Judges are expected to renew all memberships and update expiration dates so that they can be assigned. If a judge has not renewed their membership or met their CPE requirements, this can prevent them from being assigned.
- 6. Judges can add comments to let the assigner become aware of certain things such as: requests for an out of state meet, request for a specific invitational, etc. Judges can choose a preferred meet in the GymJas system, but it is not a guarantee, especially if specific judges have been requested.
- 7. If a judge is assigned a meet and then declines, he/she cannot be assigned to another meet that same weekend. (Unless there is an extenuating circumstance) If a judge receives a red flag after 2 weeks of not accepting a meet, they will receive an email and given 1 additional week to accept the meet. If no acceptance has been made, the assigner will remove the judge from the meet.
- 8. Judges, please update your availability periodically, in the event that a replacement judge is needed. When there is a quick turnaround, judges may receive a text message in lieu of an email. It important to remove dates as your availability changes as well as making sure your contact information is up to date.
- 9. The assigner works hard to rotate judges on different events throughout the season.
- 10. Judges are not required to carpool, but it is appreciated. Assignments are done at times, with the hope that judges who live in close proximity to one another, would consider carpooling. However, this cannot be mandated.
- 11. State meet assignments are selected by a board, not the assigner.
